Like most teenage boys of a certain vintage, I had a passing attraction to Belinda Carlisle. Never did I imagine that some 30 odd years later, her song about weather patterns would hold so true and effect the operations of Football within NSW. And rain it did. I'll delve deeper into the impact this had on our season elsewhere, but after 2 affected seasons, it felt that we couldn't take a trip this season. But we persevered, and I'm immensely proud of the tenacity and cooperation that all of the football ecosystem in ESFA showed in finding a path forward. That we were one of the very few Associations that delivered a full season (on-time), illustrates the power of what can be achieved when we all work together.



I'd like to start by acknowledging the support afforded to ESFA by our Patrons, Matt Thistlethwaite, Tanya Plibersek, Dr Marjorie O'Neil, Ron Hoenig, Michael Daley, Dylan Parker, Paula Masselos, Susan Wynne and the administration and fields teams of the respective Local Government authorities that we operate within, Randwick City Council, Bayside Council, Waverley Council, Woollahra Council, Moore Park and Centennial Parklands Trust, and City of Sydney Council. That we were able to play a full season is testament to the high-quality facilities that we are afforded here in the Eastern Suburbs and the community minded approach that all our LGAs took in ensuring that our participants were able to get on a park where possible.

I'd also like to acknowledge the contributions of my Board this season. I'm constantly pinching myself that

I have access to such a diverse of dedicated, forward-thinking, and importantly, empathetic group to drive the strategy of the Association forward. I appreciate their constructive feedback and ability to cut through to the crux of issues. I truly appreciate their efforts and I'm excited to see the contributions of our newcomers of the coming months and years.



The ESFA team, led by Bill, continue to amaze me with their efforts. There's no such thing as a normal week in sports administration and the continuously changing demands from stakeholders, and challenges provided by external factors (ie weather, COVID etc) can make BAU operation difficult at times. But the way the team rise to the effort and going above and beyond (no one wants to be waking up at 6am on a Saturday and Sunday rescheduling games after dealing with late registration of a player at 11:34pm on Friday night). Greg, Caroline, and Dwayne have created good structures this season and I look forward to seeing the fruits of their labours next season in a more normal season. Where they excel is in the 'grey', and whilst I periodically receive feedback about decisions that are made, I must say that on the balance of outcomes - the team consistently get the job done and make the right call. Jaime has continued to make great strides forward in Coach education and we've seen some great initiatives this year. I'm particularly excited to see the benefits of the work he has done on the syllabus and the introduction of our Centre for Excellence next season. The Sydney FC partnership led by Sarah continues to flourish and we've been able to attract some very good participation numbers at our clinics - and nothing beats the smile on a kids face as they meet their heroes and do a lap of the field at a Sydney FC home game. Lastly, Rio has added some great



social media presence that our participants and Clubs have engaged with.

I'd like to call out Bill's contribution to the Association as he leaves us to relocate Perth. Bill's tenure at ESFA has been afflicted with much personal, and professional turmoil but he has always kept his sense of humour, and fiery sense of what is right and wrong. I believe ESFA is in better shape for his service, and I'm sad to see him go - though I'm sure he won't miss my rambling phone calls at all hours of the day and night!

The above is not to say that there aren't areas where we can improve to better service our membership and we have a razor like focus on addressing certain areas moving forward. I'd like to thank the leadership from our Clubs in providing feedback over the year via various forums. As a general comment, the interests of our Clubs are varied and service numerous elements of our Community (as it should), and at times we can't make decisions that meet everyone's wants - sometimes someone has to lose in a binary decision - but the mantra that we have instilled is that decisions need to be consistent and considerate of all the facts (which sometimes may not be apparent to all parties), and the operating laws that guide the Association.

In referencing Club leadership, I would also like to thank all the volunteers and administrators that exist within the ESFA eco-system. This season especially was trying (as were the last 2), and I know for a fact that many administrators and RTOs were at wits end dealing with games reschedules etc. But the fact we were able to deliver a full season is testament to the hard work you all put in. Whilst it's at times a thankless task, I'm sure all the smiles that I saw on playing fields made it worthwhile.

Many congratulations should go to Denys Antonov and the Referee Branch Committee for the improvements that we've seen across the branch. For a number

of years, the ESFARB has been one of the 'burning platforms' within the Association, and Denys and team have rolled up their sleeves and we're starting to see some tangible results. Still work to do, but we're seeing some pleasing steps in the right direction.

In closing, I believe we've seen continued improvements this year with the restructuring of various guiding mechanisms of the Association and I feel enthused that the strategic plan that we've established is well in hand. Some of the major strategic decisions that we enacted of the past couple of years have provided some real-life efficiencies to participants, administrators, and the ESFA Competitions team. We remain focused as a Board to continue the evolution of ESFA and if anything, we will double down on our efforts.

However, in order to achieve real progress, the Association needs to bind together and work collaboratively. Whilst I understand the tribalism of sport and the want to win, at certain times we need to take a step back and ask ourselves what is the right thing to do for the game of Football in the Eastern Suburbs of Sydney? GENERAL MANAGER'S REPORT

Thus far my time at ESFA has been interesting. Season 2019 went well. Seasons 2020 and 2021 were impacted by COVID-19. Season 2022 the rains came, and they kept on coming.

The good news is, that unlike some Associations, ESFA managed to get a season of Football in, which included a finals' series. In short this would not have been possible had it not been a collaborative approach between ESFA Office staff, ESFA Board, Club Representatives, Referees, Coaches, Players, Councils, and many others. From an ESFA Office perspective Head of Competitions Greg Storey, Competitions Manager Caroline Oakes-Ash and Match Review Officer Dwayne Leverett showed great resilience, did a mountain of work rescheduling fixtures, allocating and reallocating referees, sometimes booking grounds. There were stressful times, but the satisfaction of getting people onto the park was extremely important to them. The Clubs working together as well was equally good. As stated earlier, collaboration was a key as well as thinking ahead at times.



With our Competitions team, they play an extremely important role in delivering our core product. The diligence, the drive and the significant output provided by Greg, Caroline and Dwayne was a big factor in us delivering a season of Football in this challenging year. Their focus was to deliver a great experience for all. The number of hours spent on the weekends was enormous and they as a team worked well together. Caroline's juggling of fixtures, Dwayne getting referees appointed to games and Greg working with them showed not only did they do their respective jobs well, but they cared.

This season also saw the Juniors having their first finals series since 2019 and the Seniors since 2020. These

days were so gratifying. Players were grateful and the games were exciting and of a good standard. The best thing for me were the smiles on people's faces. Team Captain's saying thank you to many during their after Grand Final speeches. That makes it so worthwhile for all concerned, especially our Club volunteers. One of the best things about Football is that it is so welcoming and so inclusive, and many people both on and off the field experience the many positive aspects that a game Football delivers.



Facilities are a clear burning issue. This season with all the rain we have had there clearly needs to be some significant investment made on pitches as well as amenities, both new and current. To do this, all four levels of Football in this country need to work together and work together with all three levels of Government. Also, within the ESFA boundary there needs to be more space made available for us to grow the game. ESFA Chairperson Nigel Singh as has done a mountain of work in this area as have Club Committees, but they need help from up higher in the Football food chain.

In saying that we did have a big win with the motion being approved by Randwick City Councillors for the upgrade of Heffron 46. Nigel's great drive and hard work was rewarded, and Football in the Eastern Suburbs will derive great benefit once this initiative is completed. The involvement of a couple of Clubs in this is much appreciated as well.

Our player registration numbers for 2022 were 8,507, a drop on the 2021 numbers where we had 9,165 registered players. I can only comment on Football, but there was a decline in player numbers right across all Associations that come under the auspices of Football NSW. In ESFA's case, one of the reasons for this decline was due to the borders opening thus enabling people to travel again.

The ESFA Pathways under our Head of Football Jaime Gomez continues to prosper. The SAP teams that compete in the Football NSW space continue to do well with the coaches focused on player development. It is pleasing to see that many of our players graduate from our Mixed Under 12's and the Girls Under 13's in to the NPL space.



The ESFA SAP Under 12's' is a great initiative and there were six teams that entered in the inaugural season. Credit goes to the Clubs for supporting this. Next season the target is for more teams to play in this program as well as start up a program for the girls.

The Minis program for two-to-five-year old's run by Rio Darlaston went well this year and provides a great link for our local Clubs once these kids are eligible for MiniRoos.

Coach Education is extremely important, and Jaime delivers programs that are critical for our aspiring coaches. Please, Jaime is there to help your coaches so utilise his services and expertise.

Programs are planned for 2023, specifically focused at growing the female participation market and taking advantage of the Women's World Cup. These include a Come & Try Program, more Girls only Gala Days (the one in March went extremely well in partnership with Sydney FC) and Female only Coach workshops and courses.

Our Community Engagement Officer, Rio Darlaston's work has been great, especially with the Social Media postings and articles she has produced throughout

the year. As a coach she is has been an integral part of ESFA's development programs. I wish Rio all the best as she will be moving to the Gold Coast at the end of the year.

The School Holiday Clinics, Skills Program and School visits run in partnership with Sydney FC continue to foster. Fan Development Officer Sarah Ferris has done a great job and will continue to grow all programs. This is a good channel to introduce new playing members to Clubs.

Thanks go to all our sponsors. To Ray White Woollahra|Paddington, Western Imaging Group, JazzRight Production Services, Deploy, Ultra Football, and Sydney FC, they are all truly valued partners of ESFA.

To the ESFA Patrons, thank you to all of them for their support of Football in the local community.

The ESFA Board, under the leadership of Chairperson Nigel Singh, are a fantastic group of people. ESFA is in excellent hands. All are very genuine people with no egos and are totally focused on delivering a great experience for all our Football stakeholders. In my opinion they have been the best Board to work under.

Sadly, this will be the last report I write for ESFA in my capacity of General Manager. Western Australia beckons on a full-time basis! It was such an emotional and difficult decision to make when I resigned. I wish I could have just somehow transported ESFA across to WA or buzz myself from the Office to home! ESFA has been one of the best places to work and will always have a place in my heart. I have met so many good people. The Board and staff were so supportive of me throughout my tenure at ESFA, especially when I was going through my illness. Thank you does not seem enough. To the folk that kept in touch with me during my illness, I am so grateful - you really did help get me back on my feet.

In conclusion, I hope the 2023 season returns to a sense of normality. The World Cup in this Country will be a great highlight and let's hope the sport thrives on this event and sets itself up for the future. Enjoy the experience of Football. Enjoy the good and limit the bad. There are people a lot worse off than us and would trade places with us. The legacy that people involved in our sport create and leave is to be applauded as well as respected. I wish nothing but good for all of you.

Eastern Suburbs Football Association Inc. Notes to the Financial Statements for the Year Ended 30 September 2022

Note 1: Statement of Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act New South Wales. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

- a) Income Tax**

No provision for income tax has been raised as the entity is exempt from income tax under Section 50-45 of the *Income Tax Assessment Act 1997*.
- b) Inventories**

Inventories are measured at the lower of cost and net realisable value.
- c) Property, Plant and Equipment (PPE)**

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.
- d) Impairment of Assets**

At each reporting date, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.
- e) Employee Benefits**

Provision is made for the association's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.
- f) Provisions**

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.
- g) Cash and Cash Equivalents**

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less.

h) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

All revenue is stated net of the amount of goods and services tax (GST).

i) Leases

Leases of PPE, where substantially all the risks and benefits incidental to the ownership of the asset, but not the legal ownership, are transferred to the association, are classified as finance leases.

Finance leases are capitalised by recording an asset and a liability at the lower of the amounts equal to the fair value of the leased property or the present value of the minimum lease payments. Including any guaranteed residual values. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for that period.

Leased assets are depreciated on a straight-line basis over the shorter of their estimated useful lives or the lease term.

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

j) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

k) Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

l) New or amended Accounting Standards and Interpretations adopted

The entity has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

Thank you to Andrew Morris (lead instructor) and Brian Dene (Football St George) for leading this course.



It was great to continue to forge the relationship with the John Moriarty Foundation through assistance with coach education and their charity event. We look forward to supporting the foundation in 2023.

For our young footballers, the season kicked off with a gala day hosted by Sydney FC. This set the tone for the season, and it was a great way to start the winter season.



The ESFA Association SAP League grew this year with the addition of Under 9s age group. Games were played in great spirit, and it was encouraging to see so many talented football players. Being in its infancy there will be many additions in 2023 to make it the showcase age groups in football. 2023 we are hoping to include our girls and launch the Association Girls SAP League.

For our All Age teams, ESFA provided regular small group goal keeping sessions held throughout the season. The initial uptake was fantastic, and the program will be run in 2023 allowing our goal keepers to have access to professional guidance.

Through our relationship with Sydney FC, the Sydney FC/ESFA Skill Training Programs, Holiday camps and School Programs were run again by our expert coaches. We also hosted the inaugural Sydney FC/ESFA Schools comp with primary schools across the east battling out to see who would be crowned champions. The involvement of schools in the overall football footprint is key to the further engagement and success of our competitions. Thank you to Sarah Ferris, our Sydney FC/ESFA Game Development Officer, for her guidance and management of these programs, which have served as an important part of football in the East.

For our aspiring Matildas and Socceroos, the ESFA Girls and Mixed SAP programs had a full season competing



against other Associations and National Premier League Clubs. Under the guidance of Dan Pyke and Sarah Ferris, the children developed over the year with our Under 12s Mixed and Under 13 Girls players graduating into NPL Football. Congratulations to all coaches, managers and players for a great season and we are looking forward to continuing the work in 2023.

As we head into a FIFA World Cup year on our shores, 2023 is looking to be the biggest season yet. ESFA has many new initiatives that will support its member clubs and players along with continuing to deliver important programs that will assist football in the East.

COMPETITION MANAGER'S REPORT

"The pessimist complains about the wind; the optimist expects it to change; the realist adjusts the sails." - William Arthur Ward

Coming off two Covid affected seasons and understanding the trepidation of players to sign up for Winter 2022, it in the end, was never going to be a virus that got us, but rather the wrath of Mother Nature, breaking records for annual rainfall! Adjust the sails.

Rain affected the preseason almost as much as the season. Clubs worked hard for player registrations and grading on muddy pitches or no pitches at all and this led to some teething issues for all age groups.

We were able to host with Maroubra United thanks to the huge efforts of Adam Lee, the annual Louise Mazzaroli Cup at Latham Park which was well attended and enjoyed by our female players in ESFA and won by Dunbar Rovers FC. This was a great opportunity to promote female football in memory of Louise Mazzaroli who gave so much of her time to the development of female football and refereeing in the Eastern Suburbs.



Pre-Season and early season saw some of our Men's Premier League Clubs campaign in the Football Australia Cup.

With MiniRoos hardly making an appearance at the parks for grading purposes pre-season due to the unbelievable amount of precipitation, we delayed the commencement of season by a week, allowing Clubs the extra time to chorale their teams. This assisted the Clubs however, on the first day of the season, we still battled the elements and not all our youngsters took to the fields.

We subsequently made the decision to increase the season for our youngsters and complete on the weekend of 20th and 21st August, which allowed most kids to



have played 14-17 matches. In the end this was a positive result for our youngest players. Adjust the sails.

MiniRoos are regraded after every 5 rounds which is based on scores and Club requests. Our battle however is to ensure there are no byes in MiniRoos and no divisions which are above and beyond grassroots footballers. An even larger battle to win, is clubs' expectations of the number of games at their fields based on field availability. If every park could be full every weekend as expected, then we as well as Clubs would be happy. Until all clubs have grounds with the same times available and the MiniRoos age groups grow,



this will continue to be problematic in the number of demands to ESFA.

Our Club SAP program provides a talent based and skills program for U9s, U10s, U11s and U12 boys with the hope to extend this to U10 and U12 girls in 2023. This program is a skill-based program and allows ESFA Club players to follow the same FA Curriculum of the Skills Acquisition Program.

The ESFA Junior competitions certainly had their fair share of challenges beyond the weather. Numbers were down in specific age groups though overall the same as previous years. This affected our U15 and U16 competitions the most with a combined 15/16 competition for both Championship and Division 2. The age groups were split however for the Grand Finals. The U18s comprised of 2 divisions which was a great result for football. It should be obvious practice that our U18s move into an U21 competition for 2023 and not straight into Senior Football.

The girls' competitions were well set except for G17 which also was combined between Championship and Division 2. Retrospectively for the greater good of football and the players, my personal choice would have been 2 divisions of 5 teams. It is hoped that ESFA has a greater opportunity to implement competitions as the governing body for the future of the girl's game. Once again, it would be beneficial to offer either a G18 competition or a Womens 21 for 2023 to keep the girls in the game especially during the Women's World Cup year. Clubs and ESFA should be looking to build off the momentum the World Cup will bring to Australia.

One of the challenges with Junior football is juggling each Club's individual demands while attempting to ensure everyone is given beneficial service. The other challenge is the lack of fields for rescheduled fixtures at a suitable time slot and the number of demands placed on reschedules. In 2023 it is paramount that ESFA lead the rescheduling (as with Seniors) and only reasonable (at ESFA's discretion) reasoning for unavailability be accepted. The Competition Rules need to be accepted more broadly by Junior Clubs. There is also the challenge of demographics with Private School children's availability on Saturdays. Whilst we have specific time slots, these have proven to not suit everyone. The solutions and debate of moving to Sundays or indeed Saturday mornings is constant and there needs to be a broader solution/cooperation between Clubs regarding the U13 and U14 mixed/boys' competitions.

In exceptionally welcome news, ESFA were able to provide the Grand Finals opportunity for our Junior Competitions for the first time since 2019. Three years without seeing our Juniors certainly provided a highly successful, enjoyable, and exciting weekend. 16 Grand Finals, 2 venues and lots of brilliant football on display. We cannot speak highly enough of the young team captain's whose speeches were as equally skilful as their football. The weather was not necessarily our friend though the show went on and we finished the season as



we started, rain and sunshine and rain, with spectators, families and supporters all enjoying the completion of season 2022.

Our Champion of Champions results were the best since 2015 in our Junior Grades. Easts G13s and Maccabi U14s making their way through to the Semi Finals was a fantastic achievement for the kids and Clubs involved.

Senior Football player numbers were down however once again adjusting the sails, we were able to grade teams accordingly and had some brilliant results throughout the season. Our seniors were all privy to 18 rounds of football regardless of the weather. Those sails adjusted exceptionally well thanks to the constant cooperation and assistance of Clubs. We had a record-breaking number of night games! This added pressure to our referees however, they too became part of the exceptional push to complete the season.

Our Men's Premier League saw a late withdrawal which resulted in an 8-team competition. We will be continually working with Clubs to build this and include Clubs who are currently not entered into the Premier League. This is a goal likely to be implemented next year to allow 2024 to see an updated Men's Premier League competition. Our Clubs however still saw their 18 rounds with the final 4 rounds seeded. This led to some exceptional games leading into our 3-week finals series,



culminating in two captivating grand finals that required 120 minutes in Reserve Grade and 120 minutes plus penalties in First Grade to complete. Congratulations to Glebe Wanderers Reserve Grade and Coogee United First Grade for becoming 2022 Men's Premier League Champions. Dunbar Rovers Reserve Grade whilst making the Grand Finals were awarded the Premiers in 2022 and Grand Final runners up.

We cannot forget the monumental season Glebe Gorillas First Grade had in becoming Men's First Grade Premiers. Whilst not appearing in the Grand Final, Glebe Gorillas had one of the best Champion of Champions campaigns we have witnessed. Representing ESFA in the FNSW Champion of Champions final is a respected and recognised achievement and winning it even better, especially against Banksia Tigers! A fantastic season of firsts for the Glebe Gorillas.



Our Women's Premier League for the first time played for prize money in parity with the Men's Competition. Whilst the League commenced 2022 with 9 teams after Lions entered the competition. Lions however were regraded back to Women's O1 and the Women's Premier League continued the season with 8 teams adjusting their sails without complaint. Coogee United were a phenomenal force and were victorious as League winners having never lost a game in the season. Football however is decided on every individual game and Sydney University took the Champions trophy in the Grand Finals which can be perceived in effect as a good news football story for WPL in that each game is individual.

Coogee United like their male counterparts Glebe Gorillas after a fabulous campaign for the Champion of Champions and a slight scare in their Semi Final which resulted in the best goalkeeping skills in a penalty shoot out you will likely ever witness, allowing the women to

move through to the FNSW Champion of Champions final! Unfortunately, it was not to be for the women of Coogee in the Final with the cruelty of football coming in on a penalty shot (extra time/golden goal) against Seaforth. Coogee WPL however should be incredibly proud of their season having won 49 games in a row and showing their strength and fortitude in promoting female football.

We can't go past the masters of Senior football with Dunbar O45 Championship winning the League, the Grand Final and winning their way to the FNSW Champion of Champions Final. Dunbar were the only team representing ESFA who were going for the treble in 2022. A feat worth celebrating for O45s football in the Eastern Suburbs. The gentlemen of ESFA took Hurstville Minotaurs to extra time and once again Golden Goal awarded the opposition the win. The gentlemen of ESFA should be proud however of their season and their Champion of Champions campaign.



This season we entered the Randwick City Purple Hearts in our Men's O35 Division 2 competition after previously entered in Men's O9 in 2021. The Purple Hearts and all they represent, were embraced by our O35's and we have nothing but praise for the respect and embrace provided by the O35's Clubs to the Purple Hearts. Our Annual Report cover photo shows the ideology and affection shown to Purple Hearts with a Coogee player swapping shirts and playing for the Purple Hearts in the second half. This was a constant throughout the entire season with all teams. A special mention to Waverley Old Boys FC who turned up at Chifley with a complete squad of 18 players and a football match that will be forever remembered by both Clubs. The Purple Hearts are an important part of our Inclusivity and Diversity program. This was the first season a female

Purple Hearts player played within our Senior Women's competition and we would wish to thank all Clubs involved.

Men's Saturday competitions grew into 6 divisions! Whilst Sunday numbers in Men were down in number post Covid and the opening of international borders, there were still a healthy 7 divisions which we would expect to grow further in 2023.

Women's football continued its growth. With 2023 FIFA Women's World Cup, the likelihood of more women entering the world of football is high.

Senior Grand Finals at five different venues stretched the staff but the embrace of the football community at all five venues was amazing! Our Grand Finals at two venues even had live streaming and downloading entire games for prosperity!

My sincere respect and admiration of Club hard working volunteers and administrators who assisted so greatly in ensuring 18 rounds of football was achieved in the seniors and at least 13 rounds in Juniors. Our MiniRoos played at least 14 rounds with some playing more if they were able to be based on synthetics.






PARTICIPATION BY AGE CATEGORY



PARTICIPATION BY GENDER




PARTICIPATION BY SEASON




PLAYER STATISTICS

MALE VS FEMALE





